The Complaint Intake Unit of the Division of Professional Regulation has referred your complaint information to the appropriate Investigations Unit to begin the investigative process. The case number that has been assigned to your complaint is listed above. The Department will conduct an investigation to determine whether there has been a potential violation of a licensing law, or Division's administrative rules. You may be contacted by a Department investigator seeking additional information. The Department asks for your full cooperation during its investigation.

If the investigator determines that there has been a violation, the investigator will refer the case to a prosecuting attorney for further processing. However, if there is insufficient evidence to indicate a violation of the particular licensing statute or the Division's administrative rules, the investigative file may be closed. Please note that pursuant to Illinois law (20 ILCS 2105/2105-117), all information collected by the Department during an examination or investigation of a licensee, registrant, or applicant is confidential and cannot be publicly disclosed. Exceptions to this law exist only for law enforcement, other regulatory agencies with appropriate regulatory interest, or a party presenting a lawful subpoena.
