**Incident Description:**

On Or About April the Suspect Christopher Stoller ( A convicted felon four times) filed a fraudulent Quit Claim transferring the property known as Lot 4960 BLK 87, Lake Como Beach, records of Walworth County, State of Wisconsin known a W3786 Woodland Dr. Walworth County Lake Geneva, stealing the property from his nephew, Michael Stoller a 32 year old disabled person, a protected person as defined by the Americans for Disability Act.

At the time of the fraudulent transfer of the said real estate Christopher Stoller 74, was subject to a Cook County Order of Protection Case No 2023OP07206 not to transfer any property from the Petitioners Leo Stoller and Michael Stoller 32.

Leo Stoller 76 conformed Christopher Stoller on May 17, 2023 and demanded that the immediately quick claim the said property back to his nephew, Michael Stoller a disable (Adult-Child). Christopher Stoller refused.
